This Committee by proceeding dated. 30.07.2020 (ref 1) issued a Schedule for
MBA / MCA and M.E. / M.Tech / M.Arch courses where in the date of conducting
Common Entrance Test for the above said courses were fixed. Thereafter the Directorate
of Technical Education Chennai has issued the Tentative Schedule for admission of

students into MBA / MCA Courses. As per the schedule issued by the Directorate of Technical Education, there may be difficulties for Self Financing Professional Arts and Science Colleges to conduct the Common Entrance Test as per the Schedule issued by the Committee by ref 1. The Consortium of Self Financing Professional, Arts and Science Colleges in Tamil Nadu / Association of Management of Coimbatore Anna University Affiliated Colleges therefore requested the Committee to modify the dates for Common Entrance Test for the above said courses for the year 2020 – 2021 stating there would be a clash with the dates of the final year examination fixed by the various Universities in Tamil Nadu. Vide ref 2 & 3. Considering the request of the Consortium / Association and also having regard to the tentative Schedule issued by the Directorate of Technical Education, the Committee decided to modify the dates for conducting the Common Entrance Test and the modified Schedule of admission for the academic year 2020 – 2021 is as follows:
